## Investment Philosophy and Objective

The fundamental investment objective of the Fund is to provide long-term capital appreciation by investing, directly and indirectly, in precious metals. This Fund invests primarily in common shares of companies engaged in the precious metals business or in precious metals in the form of bullion, coins or storage receipts. Precious metals are gold, silver, platinum and palladium. Investments by the Fund in common shares are made primarily in North American companies which, in the case of producers, may derive a substantial portion of their revenue from sources other than the production of precious metals. From time to time the Fund may invest, to a lesser extent, in other kinds of securities (including preferred shares and debt securities) to achieve its investment objective. The Fund will be managed in a manner to achieve optimum diversification.
