Prior to founding Sun Valley Gold in 1992, Mr. Palmedo worked for Morgan Stanley & Co. in New York from 1981 until 1989, where he was a Principal of the firm. He specialized in equity derivatives, including portfolio risk management, portfolio insurance, and the development and analysis of synthetic and imbedded options and warrants. SVG manages funds and provides advisory services for institutions, mutual funds, pension funds, family offices, and corporate clients around the world. Mr. Palmedo has made presentations at the Financial Times World Gold Conference, Nikkei Gold Conference, Gold and Silver Institute Annual Conference, IMN Hedge Fund Investors’ Summit, the Global Alternative Investment Management Forum, and the Morgan Stanley Eleventh Global Investment Seminar. Mr. Palmedo has been interviewed by The Wall Street Transcript, The Financial Times, Forbes, CNBC, and Bloomberg News.
